  - A: Meal plan expires after second year, not taxed in first year, taxed in second year (status quo)
  - B: Meal plan never expires but taxed the entire time
- Have reached out to financial officer following meeting, haven't heard back

### Miscellaneous Updates:

Met with Axel (MAUT) following his comments about the tenure process and students' calls for inclusion of the disciplinary record in the tenure dossier

- Had a productive discussion, main point of contention is still that Axel does not believe that tenure should involve a moral consideration (I disagree)
- Will be looking into (read: looking for an associate senator to look into) specifically how the disciplinary process for professors works
  - Hope to convince Axel that there is no way someone could be penalized (on the disciplinary record) for an intellectual disagreement

### **Committee Work:**

- The APC met on October 25th and voted on three proposals
- One was a new exchange program with three new partner universities: École Polytechnique of the Université Paris-Saclay, Aristotle University in Thessaloniki, University of Haifa in Israel
- The second proposal was a change in the approval process for new exchange partners
  - Prof. Oxhorn, Associate Provost (International), proposed to be permitted to expand the exchange programs with already existing partners without having to come before the APC every time.
  - The committee voted against this for the time being because we wanted to be able to see what criteria he would be using to make such calls
- The second proposal was changing the name of the Department of Ophthalmology to the Department of Ophthalmology and Visual Sciences
  - This passed unanimously
- The last part of the meeting was dedicated to a discussion surrounding the new student code of conduct and our thoughts on the changes made, it is not finalized yet it is still being worked on
  - An important change that is being made is the University's definition of University Context, previously McGill only considered matters that happened on its campuses a University Context now the definition has been expanded to include the following
  - (o) The "University Context" means circumstances occurring:
  - (a) on University premises; or
  - (b) within a University-sponsored program, event or activity whether on-campus or off campus;
     or
  - (c) off-campus, including online or in social media, where the conduct has consequences that may be reasonably
  - seen to adversely affect:
    - (i) the security of students, academic, administrative and support staff while on campus or while participating
    - in a University-sponsored program, event or activity; or
    - (ii) the right of a member of the University community to use and enjoy the University's learning or working
    - environment.

### **Committee Work:**

- Second meeting for Committee on Enrolment & Student Affairs (CESA) happened on 16<sup>th</sup>
   Oct
  - Continuation of the same conversation from last meeting regarding terms of reference for scholarships
  - Will vote on amended terms of reference for scholarships in the next meeting
- Career Planning Service (CaPS) Advisory Board meeting happened on 25<sup>th</sup> Oct
  - MyInvolvement (co-curricular transcripts) is now under CaPS and they are trying to revamp the forum
  - o CaPS office in Brown Building is changing their book loaning policy
    - They don't have a circulation system so can't put holds on accounts
    - They normally take student IDs or \$20 security deposit
    - Books are worth much more than \$20 deposits and so there have been cases where students have not returned the books despite warnings via email/call
    - Trying to communicate with Student Accounts Office to develop an effective policy
    - Increasing loan time to one week instead of the current overnight rule
  - o A lot of the issues in CaPS are because of lack of funding
  - CaPS organized a survey (10% participation rate from 7000 students) and found that most students have use their services at some point in their university life
- Scholarship and Student Aid Office (SSAO) Advisory Board happened meeting on 26<sup>th</sup> Oct
  - Most members were new, so the meeting was basically an overview of SSAO's services
  - o Presented us with a statistical report on last three year's performance
  - Next 12 months are crucial as the University is going to decide how much money goes to SSAO because of the tuition fee deregulation

- Engineering Undergraduate Society (EUS) Council meeting happened on 3<sup>rd</sup> Oct
  - o Jeremy Garneau, will be my replacement for this semester
- Engineering Board of Governors (BoG) meeting happened on 21st Oct
  - o The Board approved the EUS budget for the upcoming year

- Scholarship Renewal Policy
  - o Met with **Cara Piperni** (Director, Scholarships & Student Aid) on 19<sup>th</sup> October
  - She reassured me that the office values equity in granting scholarships
  - Agreed to compile faculty-specific data after which I followed up with Myrosia Cap who will be compiling this data
  - o She mentioned how it will take time to compile this data
  - o I assume from our meeting that she will get back to me by the latter part of November after which we can analyze the data and start working on an alternate policy (if one is needed)

  - O Communicated with EUS VP Academic, Niloufar Seraj, to nominate one of the departmental VP Academics from Engineering on the Ad-Hoc Committee

While pop-up clinic should be relatively 'anonymous', promotion would need to be done in terms of outreach events.
